A) The envelope of Technical offer shall contain the following documents:

- 4. General Terms & Conditions – Annexure – I**
- 5. GST registration certificate to be attached.**
- 6. Registration of Pollution Control Board Certificate**
- 7. MSME registration certificate /National Small Industries Corporation registration certificate) if applicable for EMD exemption.**
- 8. Copy of Photo identity. (Aadhar Card/ Pan Card/ Driving License)**

Annexure -I - Terms & Condition

1. EMD will be converted into security deposit of Rs. 20,000/-
2. Contractor has to pay applicable Govt Taxes (GST) & other taxes as per rules and regulations.
3. Contractor has to provide G.S.T certificate copy.
4. Scrap contractor has to lift the material within 7 days as & when informed by the management.
5. Scrap contractor has to lift the material on as is where is basis.
6. Contractor has to deposit the value of scrap in account department of the Office after the loaded vehicle is weighed on Dairy weighing bridge.
7. Scrap contractor has to lift all scrap material regularly within 15 days.
8. If contractor does not lift the material in time, contract will be cancelled & we may forfeit the security deposit.
9. The vehicle for the scrap lifting & carrying will be arranged by contractor at their cost, the contractor has to make arrangement for loading of scrap.
10. Prior to loading of scrap the vehicle will be weighed at plant weigh bridge & then loaded vehicle will be weighed at plant & then Net scrap weight will be calculated. Net weight of material would be calculated for payment of quantity of scrap based on the quoted price. After payment the vehicle will be released.
11. While taking delivery of scrap, the contractor should take only sold scrap, if he is found taking other then sold material, his contract will be cancelled & we may forfeit his security deposit.
12. Scrap contractor should take all the scrap material of contract awarded to him without any objection.
13. Tenders without Earnest Money Deposit will not be accepted.
14. Scrap material will be delivered between 10 AM to 4 PM from Monday to Friday on working days.

15. Scrap contractor should dispose off all scrap material as per norms of Pollution Control Board. The contractor has to give under taking for the same.
16. Scrap contractor should have registration in Pollution Control Board for disposal of scrap material.
17. Conditional Tenders will not be accepted.
18. If any dispute or difference shall arise between the parties hereto relating to this agreement or the interpretation thereof or in any other matter in any way arising out of or connected with the subject matter thereof, the same shall be referred to the Administrator /Chairman of the Goa Milk Union. The decision of the Administrator/Chairman in the matter shall be final and binding on both the parties.
19. The Union reserves the right to accept or reject any or all the tenders without assigning any reasons whatsoever.
